ALL ELECTORS ARE HEREBY GIVEN NOTICE that a Special Election will be held in Unadilla Township, Livingston County at the Unadilla Township Hall 126 Webb St., Gregory on Tuesday, May 2, 2017 from 7:00 A.M. to 8:00 P.M., at which time the following ballot proposals will be presented at the Special Election:

**TOWNSHIP OF UNADILLA
DUST AND ROAD IMPROVEMENT MILLAGE PROPOSAL**

Shall the tax limitation on all taxable property within the Township of Unadilla, Livingston County, Michigan, be increased and the Township be authorized to levy a millage in the amount not to exceed 1.0 mill (\$1.00 on each \$1,000 of taxable value), of which .9834 mill is a renewal of the millage rate that expired in 2016 and .0166 mill is new additional millage to restore the millage rate previously authorized, for eight (8) years, 2017 to 2024 inclusive, to provide funds for dust control and road improvements? The estimate of the revenue the Township will collect if the millage is approved and levied by the Township in the 2017 calendar year is approximately \$107,000.

**TOWNSHIP OF UNADILLA
POLICE MILLAGE PROPOSAL**

Shall the tax limitation on all taxable property within the Township of Unadilla, Livingston County, Michigan, be increased and the Township be authorized to levy a new additional millage in an amount not to exceed 2.5 mills (\$2.50 on each \$1,000 of taxable value) for eight (8) years, 2017 to 2024 inclusive, the purpose of operating, equipping, and purchasing for the police department or any other police service purpose authorized by law? The estimate of the revenue the Township will collect if the millage is approved and levied in the 2017 calendar year is approximately \$268,000.

**TOWNSHIP OF UNADILLA
FIRE MILLAGE PROPOSAL**

Shall the tax limitation on all taxable property within the Township of Unadilla, Livingston County, Michigan, be increased and the Township be authorized to levy a new additional millage in an amount not to exceed 1.5 mills (\$1.50 on each \$1,000 of taxable value) for eight (8) years, 2017 to 2014 inclusive, the purpose of operating, equipping, and purchasing for the fire department or any other fire service purpose authorized by law? The estimate of the revenue the Township will collect if the millage is approved and levied in the 2017 calendar year is approximately \$161,000.
